The Education Team is looking forward to meeting you during your upcoming tour of the County's ReSource Center and Tajiguas Landfill! Free group tours are offered to adults that live in the waste-shed of the facility. If you live in the cities of Santa Barbara, Goleta, Buellton, Solvang, parts of Santa Ynez Valley, as well as many unincorporated areas on the south coast; your waste is coming here! Waste is managed much differently in other parts of the area and we want the presented information to be relevant to all visitors.

We encourage carpooling to the site. We have a maximum number of 5 cars per group allowed inside the entrance due to limited parking at the Education Center (we may park a few cars before the entrance and consolidate into fewer cars).

Please bring the printed and signed liability waiver with you to the tour. We will also bring extra copies if you forget.

<u>Written directions from Santa Barbara</u>: The facility is 26 miles from the Santa Barbara City center on the Gaviota Coast. Coming from Santa Barbara, get on the 101 North. Once you get to Refugio State Beach, you have 4 miles to go. You will see a deceleration lane to the right and a lone palm tree where you will exit. There is no exit sign. Drive forward and **pull off to the right side area before the entrance gate to meet your group and tour guide.**

<u>Written directions from North County:</u> On the 101 South you will reach the coast and drive for a few minutes and see the Mariposa Reina Exit, continue driving for 4 miles, look for "Vista Point" signs on your right hand side and then enter a deceleration lane on your left hand side. There is no exit sign. You will carefully cross over the 101 northbound side of the freeway. Drive forward and **pull off to the right side area before the entrance gate to meet your group and tour guide.**

I further understand that accidents and injuries can arise out of the event; knowing the risks, nevertheless, I hereby agree to assume those risks and to release and to hold harmless the County who (through negligence or carelessness) might otherwise be liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my heirs and assigns.
