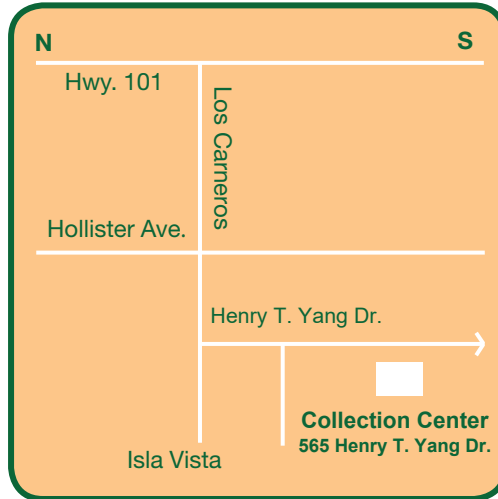

## COMMUNITY HAZARDOUS WASTE COLLECTION CENTER

The Community Hazardous Waste Collection Center (the "Center") is administered by the Santa Barbara County Public Works Department in partnership with the University of California, Santa Barbara ("UCSB") and the cities of Goleta and Santa Barbara. The Center is located on the UCSB campus, Henry T. Yang Dr., Building 565, and serves residents and businesses located within the unincorporated area of Santa Barbara County, and the cities of Goleta and Santa Barbara. The Center is available two days a week (Saturdays and Sundays) to residents and once a week (Fridays) to businesses.

### BUSINESS ELIGIBILITY

State and Federal hazardous waste laws limit the use of this type of hazardous waste collection program to businesses that qualify as Conditionally Exempt Small Quantity Generators ("CESQGs"). To qualify as a CESQG, a business must not produce more than 27 gallons or 220 pounds of hazardous waste per calendar month, including a maximum of 1 kilogram (1 quart or 2.2 pounds) of acutely hazardous waste. Businesses that generate more than this amount are required to use a licensed hazardous waste hauler to manifest and transport their waste.

To be eligible to use the Center, businesses must be from the unincorporated area of Santa Barbara County, or the cities of Goleta and Santa Barbara. Businesses will be required to sign a waiver stating that they are a CESQG and understand they are required by law to have a State or Federal identification number ("EPA ID number") as a handler of waste. ### QUANTITY LIMITATIONS

**A maximum of 27 gallons or 220 pounds of hazardous waste will be accepted at the Center per business per calendar month.**



### BUSINESS APPOINTMENTS

Businesses and all non-households (including churches, schools, public agencies, property management firms, and non-profit groups) must make an appointment to use the Center. Appointments are scheduled for Fridays only. To make a Friday appointment, please visit [www.LessIsMore.org/biz-haz-waste](http://www.LessIsMore.org/biz-haz-waste) Monday through Thursday to request an appointment time. **Businesses and other non-households are prohibited from using the Center on the weekend household collection days.**

### TRANSPORTING & LABELING WASTE

Caution should be taken when transporting hazardous waste to the Center. If possible, use the original product container or label the container if contents are different than listed. Cover all containers with a secure fitting lid and pack containers upright in leak-proof boxes. Containers must be no larger than 5 gallons each. The business should compile a detailed inventory of the waste being transported and should be able to provide the list upon request. State transportation laws limit the amount of hazardous waste that may be transported by businesses to 27 gallons or 220 pounds.

### DISPOSAL FEES

Businesses will be charged a user fee of \$30.00 for processing/administration costs plus a disposal fee based on the types and quantities of waste (see price list). Non-profit organizations and schools receive a 25% discount, and the user fee is waived.
